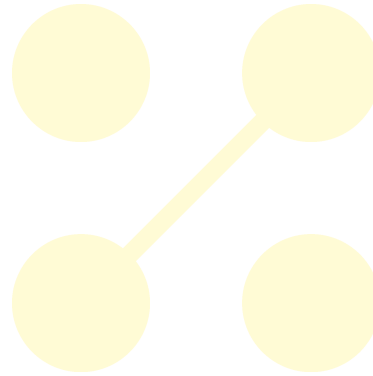

- Your legal representative is welcome to attend the mediation sessions

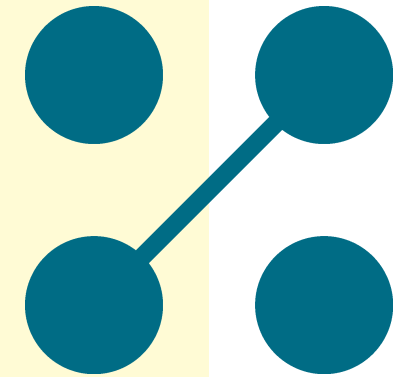
